GENERAL TERMS & CONDITIONS

Thank you for giving us the opportunity of your business. Please read the following Terms and Conditions complete and return the attached application for monthly account facilities for our consideration.

1. Credit will not be granted until the application form is fully completed and references taken up and reviewed.
2. Credit facilities only apply to parts, accessories, oils, lubricants, accident damage, vehicle service and repairs.
3. **Payment terms are settlement by 20th of the month following the month of purchase.**
4. Interest may be charged at 2% per month on accounts not settled within the terms of payment set out in 3 above, at the discretion of Midlands Truck & Van Ltd.
 - a) Midlands Truck & Van Limited may demand the immediate repayment of all amounts outstanding on the credit account.
 - b) We reserve the right to re-invoice any trade discounts allowed should these terms and conditions not be observed.
5. Midlands Truck & Van Limited shall not be liable either in contract or tort for any defective goods or of any loss suffered by the customer either directly or indirectly by any failure of Midlands Truck & Van Limited to comply with it's obligations under any contract between itself and the customer. Nothing in these conditions excludes or limits the liability of Midlands Truck & Van Limited for death or personal injury caused by one company's negligence or for fraudulent misrepresentation.
6. Midlands Truck & Van Limited shall not be liable for any failure to or delay in the supply of goods or services caused by circumstances beyond it's control.
7. (i) Midlands Truck & Van Limited shall retain title to any goods supplied by it until payment in full has been received. If goods supplied have been converted to other goods the title of the other goods shall remain vested in Midlands Truck & Van Limited as if they were the original goods supplied.
 - (ii) The customer authorises Midlands Truck & Van Limited to enter into the customer's land and/or premises to recover goods the title to which have remained vested in Midlands Truck & Van Limited.
 - (iii) If goods the title to which remains vested in Midlands Truck & Van Limited have been sold the customer agrees that Midlands Truck & Van Limited shall have the right to the proceeds of sale of such goods to the extent of any monies due to Midlands Truck & Van Limited from the customer whether in relation to this or any or any other contract and such monies shall be deemed to be held by the customer in trust for Midlands Truck & Van Limited.
 - (iv) Risk shall pass on delivery of goods notwithstanding that title does not pass until payment.
8. Periodical reviews will be carried out on account activity and credit facilities may be withdrawn at any time. Accounts that are dormant for more than 12 months may be discontinued. Accounts can only be re-opened on re-application.
9. Failure to comply with our Terms and Conditions will result in withdrawal of credit facilities and any sums outstanding will become payable immediately.
10. The provision of the credit account will be reviewed periodically and Midlands Truck & Van Limited may at any time, in its absolute discretion, decide upon written notice to the customer, to withdraw such account. Upon withdraw the customer shall pay to Midlands Truck & Van Limited forthwith an amount equal to the amount outstanding on the account.
11. Midlands Truck & Van Ltd reserves the right to decline any application without giving reason.
12. All queries raised against any invoice must be sent in writing to our Birmingham Head office, or faxed to the accounts department, 0121 326 4716, within 14 days of statement date. Queries received later than 14 days of statement date may not be accepted.
